**TRAINING-WORKSHOP ON THE DEVELOPMENT OF READING
ASSESSMENT TOOL AND INTERVENTION MATERIALS
IN ARABIC LANGUAGE**

1. In line with DepEd Order 173, s. 2019, re: Bawat Bata Bumabasa, producing productive and responsible citizens equipped with essential competencies and skills for lifelong learning, this office will conduct the Training-Workshop on the Development of Reading Assessment and Intervention Materials in Arabic Language on June 22, 24, and July 7, 2023 at Kuya Dong Restaurant, Mangagoy, Bislig City.

 - a. Identify the purpose and benefits of reading assessment;
