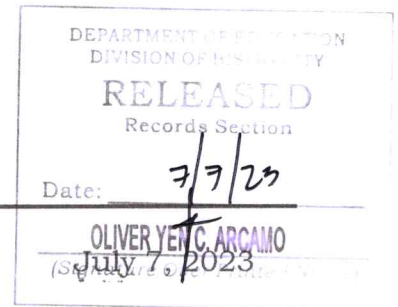

1. Pursuant to Regional Memorandum No. 0613, s.2023 re: Request for information of members of the Child Protection Committee in schools dated July 4, 2023, all public and private elementary and secondary schools shall establish a Child Protection Committee which shall be composed of the following:
 - a. School Head/administrator – Chairperson
 - b. Guidance Counselor/Advocate – Vice Chairperson
 - c. Representative of the Teachers as designated by the Faculty Club
 - d. Representative of the Parents as designated by the Parent-Teachers Association.
 - e. Representative of pupils, students, and learners as designated by the Supreme Student Government Council, and
 - f. Representative from the community as designated by the Punong Barangay, preferably a member of the Barangay Council for the Protection of Children (BCPC)
