1. In line with the mandate of Republic Act No. 11206 otherwise known as the Secondary Career Guidance and Counseling Act of 2019, there will be a Division Orientation on Career Pathing to ALS A and E Junior High School passers for the School year 2022-2023 on July 31, 2023, in Bonsai River View Inn, Baybay 1, Poblacion, Bislig City in two batches: Batch 1: Bislig 1 to 5 from 8:00-12:00 Noon while Batch 2: Bislig 6-10 from 1:00 to 5:00 PM.
2. This One-day endeavor aims to:
 - A. Equip our ALS A and E JHS passers with relevant information that will properly aid them to decide the track in the SHS that is aligned to their KSA;
 - B. Clarify issues that will empower them to intelligently choose their career;
 - C. Acquaint on the policies governing the implementation of ALS-SHS and
 - D. Value the importance of aligning one's KSA to the preferred track.
3. The ATs are mandated to secure a Parent's Permit for those learners below 18 years old and a waiver for those learners who are more than 18 years old.
4. There will be a Pre-Work conference on July 27, 2023, from 2:00 to 5:00 PM with the Program Management Team at Old DCR Building. The Management of Learning shall be hosted by Bislig 6 and 7 ATs.
