CASCADING REGIONAL MEMORANDUM NO. 0597 S. 2023, RE: REITERATION OF THE COMMITMENT OF THE REGIONAL OFFICES, SCHOOLS DIVISION OFFICES, AND THE SCHOOLS IN MAINTAINING ALL LEARNING RESOURCE FACILITIES IN COMPLIANCE WITH DEPED MEMORANDUM NO. CT-2023-168

Public Schools District Supervisors
School Principals
School Learning Resources Coordinators
All Others Concerned

1. Pursuant to **DepEd Memorandum DM-CT-2023-168**, Regional Offices, Schools Division Offices, and all Schools are mandated to materialize their commitment to maintaining **Learning Resources Facilities** at their respective level of governance.
2. All key officials and all other responsible personnel in this division are hereby compelled to make **concrete necessary actions** in putting up or maintaining an infrastructure that makes learning resources/reading materials readily available for all learners to support the agency's thrust in improving the quality of basic education.
3. Established Learning Resources Facilities such as but not limited to School Libraries and Media Centers, Decentralized Learning Resource Hubs, Reading Nooks, Science, Math, EPP/TLE Laboratories, and the like are properly maintained. It is also enforced that these instrumentalities continue to serve the multipurpose functions to which various Learning Resource processes and activities are expected to be facilitated.
4. It is further instructed to have the said facilities be continuously improved and updated for effective and efficient delivery of intended services. Specifically, schools are expected to cater to the day-to-day academic needs of the learners and teachers for this purpose.
5. Immediate dissemination to all concerned and compliance with this memorandum are highly required.
